Forging France along the Rhine: Cultural Conflict and National Identity in Alsace-Lorraine, 1919-2006 (Book Manuscript – expected date of completion, August 2009)

This book uses the contested borderland of Alsace-Lorraine to rethink critical aspects of French and European history. The book questions the assumption that nationalism was less problematic in well established nations such as France and Great Britain, and uses debates over citizenship and nationhood on France's eastern border to show how, in a highly centralized state, nationalism was not simply imposed from above, but shaped by contentious grassroots conflict. My work also underscores that frontier regions provide a unique window for writing the history of Europe.
